

#### **CULTURAL CONNECTION GRANT**

The Cultural Connection Grant program is made possible by the Arts Council of Indianapolis and facilitated by Big Car Collaborative. The Cultural Connect Grants will enable artists and community-based organizations and other entities doing cultural public programming in Marion County to apply for funding to support artist engagement in community-centric events. Grants ranging from \$500 to \$5,000 will support the hiring of local artists (residing in Marion county) of all disciplines for community-planned projects, festivals, and/or events. Any expenses incurred after August 1, 2021, and/or planned through December 31, 2021, will be eligible for funding. Expenses incurred prior to August 1, 2021 will NOT be considered for funding. Awards to activations and events in lower-income communities and communities with high percentages of people of color will be prioritized. Applications will be reviewed on a weekly basis from October 3-24. Applicants who are not awarded in previous rounds will be automatically considered for funding in the following rounds until all funds are distributed. Apply here.

# Who is eligible?

Individual artists, community-based organizations, and other entities offering public programming (does not need to be a 501c3 nonprofit organization) in Marion County. Applicants can include Marion County-based arts organizations and individual artists collaborating with other entities.



### **Funded activities will:**

- Take place in Marion County downtown and in neighborhoods across the city.
- Prioritize free, open, accessible, and/or affordable events that are also accessible via public transportation.
- Adhere to racial equity priorities outlined below.
- Support artists of all disciplines who reside in Marion County. We consider artists to include curators, visual artists, public artists, teaching artists, spoken word poets and other literary artists, performing artists, musicians, theater performers, placemakers, socially engaged artists, etc.
- Prioritize events that include cultural programs and neighborhood engagement and
  activations in public spaces anywhere in the city of Indianapolis. Downtown locations
  may include Monument Circle, Georgia Street, Lugar Plaza, and the Canal, Indy's
  Cultural Districts, Indy Parks, and neighborhoods of special interest to the City, including
  the three identified <u>LiftIndy communities</u>, <u>LISC's five Great Places neighborhoods</u>, and
  Reconnecting to our Waterways (ROW)'s six waterway districts.
- Take place after August 1, 2021 and/or planned through December 31, 2021.

### **Use of Funds**

The primary purpose of these funds is to provide paid opportunities for artists to engage in community activations and events. Secondary fees may also include marketing (designer fee, promotional materials, website fees, ads, social media costs), program supplies, equipment, or venue/rental fees.

## This grant will not fund:

- The development of conventional, private studio work for a typical exhibition format
- Artistic commercial businesses: e.g. wedding photography, florists
- Proposals whose sole or primary purpose is to purchase or rent equipment, to meet travel expenses, or to pay for professional services
- Travel expenses
- Food and beverages
- Lodging

## **Equity Priorities:**

# **#INDYKEEPSCREATING**

- Ensure diverse decision-making representation and an equitable selection process within the overall scope and for each initiative
- All activations will uphold the #IndyKeepsCreating <u>Pledge</u> Safety, Equity, Innovation, Collaboration
- All activations must meet/exceed COVID-19 safety protocols and State of Indiana, Marion County, and City of Indianapolis public health guidelines
- Funded experiences will prioritize open/accessible/affordable events and all content will be appropriate for all ages
- All artists engaged through this program must be paid a competitive wage, included in the application
- At least 47.5% of all artist investments (both dollar investment and number) will support engagement by artists of color
- Investments in vendors/curators/contract partners (both dollar investment and number) minority- and women-owned businesses are encouraged (city's list: https://www.indy.gov/activity/find-omwbd-contractor)

# What kind of proposal is likely to get funded?

- A program/event that makes a good case that this is the right project at the right time for a particular place is very likely to get funded.
- Program/events that show authentic partnerships between an artist and a neighborhood are more likely to get funded. Ideally, the artist lives in the same neighborhood where they will be doing the project, but it is not a requirement.
- The program or event is purposely addressing and promoting the inclusion of community members and underserved audiences. Programs/events that take place in low-income neighborhoods are encouraged.
- The program/event is accessible to the public and aligns with the equity priorities of this grant.
